The fencing club training sessions are held every Wednesday from 18:00 – 20:00 hours. The fencing slot time during Monday lunchtime can also be used however, only with prior notification.

Traditionally there will be no fencing during the vacation period July and August.

Membership can start at any time during the year. The initial four weeks are considered the Trial Period and the fee for this trial period shall be paid within the first week. The membership fee, minus the fee for the trial period, until the end of the year is prorated and based on the annual fee as stated below. This fee is to be paid within five weeks from the starting date. Your membership is renewed automatically at the beginning of the calendar year, unless you notify the club's Secretary before 1 December in writing that you do not wish to continue your membership.

KNAS membership - 2023 (age 21 years and older)	EUR 63,30 per annum
KNAS membership - 2023 (age 20 years and younger)	EUR 31,65 per annum

The fees listed above include the use of the ESA/ESTEC fencing facilities during the fencing slot times, the use of the club's fencing equipment and weekly group/individual lessons provided by our fencing teacher(s). However, it is understood that when you continue your membership after the Trial Period you agree to begin to invest in your own fencing equipment. Information on what to purchase can be obtained from the fencing teacher(s), or the Committee members.

The ESA/ESTEC Fencing Club is a member of the Royal Dutch Fencing Association (KNAS). Each member of the ESA/ESTEC Fencing Club (except those in the Trial Period) needs to become a member of the KNAS in order to be covered under the KNAS collective liability/third party- and accident insurance. This is a request from the SSCC in order to ensure that all club members are insured and to reduce the liability against ESA/ESTEC.

The ESA/ESTEC Club's membership fee, or fee for the Trial Period, is to be transferred to the ESTEC Fencing Club account at the ABN AMRO bank account nr. **NL95 ABNA 0567 9090 18**.

Please note that the General Conditions attached to this form apply to the membership of all external fencers.
